The undersigned, acting as incorporator or a corporation under Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation.

I. NAME OF CORPORATION:

The name of the corporation is GREAT OUTDOOR DAYS, INC.

II. PRINCIPAL OFFICE:

The principal office of the corporation is located at 1925 E. Irlo Bronson Memorial Highway, Kissimmee, Florida 34744.

III. MAILING ADDRESS:

- V. DURATION / MEMBERSHIP

The period of duration is perpetual. The qualification of members, if any, and the manner of their admission shall be regulated by the bylaws.

#### VI. INITIAL BOARD OF DIRECTORS

#### VI. INCORPORATION:

#### VII. CORPORATE PURPOSES:

The purposes for which this corporation is formed are exclusively charitable, and educational, and consist of the following.

- 1. To encourage the responsible use and promotion of the environment.
- 2. To encourage the community to provide the necessary resources to allow the public to enjoy the outdoor opportunities of Central Florida.
- To inform the community and visitors about issues, programs and events, impacting or having to do with the environment and the enjoyment of the Great Outdoors.
- 4. To create and manage events that bring together and educate residents and visitors on conservation and responsible use of our natural resources.
- To aid, support, and assist other corporations, funds and foundations and other organizations operated for promoting the environment and enjoyment of the Great Outdoors.
- 6. All of the foregoing purposes shall be exercised exclusively for charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under the section 501 (C) (4) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

#### XI. 501 (C) (4) LIMITATIONS:

- 1. Corporate Purposes: Not withstanding with other provisions of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c) (4) of the Internal Revenue.
- 2. Exclusivity: The Corporation is organized exclusively for charitable and educational purposes.

- 3. No Private Inumment: The Corporation is not organized nor shall it be operated for the primary purpose of generating monetary gain or profit. The Corporation shall not distribute gains, profits or dividends to the Directors, Officers or Members thereof (if any) or to any individual, except as reasonable compensation for services actually performed in carrying our the corporation's charitable and educational purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable and educational purposes, no part of which shall inure to the benefit of any individual.
- 4. Dissolution: Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501 (C)(4) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes.
