## AMENDMENT TO ARTICLES OF INCORPORATION OF HERITAGE OAKS TOWNHOMES OWNER'S ASSOCIATION, INC

The undersigned as Secretary of Heritage Oaks Townhomes Owner's Association, Inc., ("Association") hereby certifies that that the Articles of Incorporation of the Association are amended as hereinafter stated pursuant to the resolution adopted December 21, 2010 by the members of the Association pursuant to F.S. 617.1006. The number of votes cast for the amendments were sufficient for approval. The amendments to the Articles are as follows:

- 1. Article VI, paragraph 6.2 is hereby amended and restated in its entirety as follows:
- 6.2 <u>Class B</u>. The Class B member shall be the Developer and shall be entitled to nine (9) votes for each Lot owned. The Class B membership shall cease and be converted to Class A membership when the total votes outstanding in Class A membership equals or exceeds the total votes outstanding in the Class B membership, or <u>December 31, 2005 December 31, 2014</u>, whichever first occurs.
  - 2. Article VII, paragraph 7.3 is hereby amended and restated in its entirety as follows:
- 7.3 Members other than the Developer are entitled to elect at least a majority of the members of the Board of Directors of the Association when the earlier of the following occurs:
- (a) three months after ninety percent (90%) of the parcels in all phases of the community that will ultimately be operated by the Association have been conveyed to members; or

## (b) December 31, 2005 December 31, 2014.

For purposes of this Section, the term "members other than the Developer" should not include builders, contractors, or others who purchase a parcel for the purpose of constructing improvements thereon for resale.

Notwithstanding the foregoing, the Developer shall be entitled to elect at least one (1) member of the Board of Directors as long as the Developer holds for sale, in ordinary course of business, at least five per cent (5%) of the parcels and all phases of the Development.

- 3. Article XII, paragraph 12.4 is hereby amended and restated to read as follows:
- 12.4 A copy of each amendment shall be certified by the Secretary of State and be recorded in the Public Records of Hillsborough Pinellas County, Florida.
