PAGE 2 JESUS CHRIST WORLDWIDE CHRISTIAN CENTER INC,

ARTICLE III

Said Corporation/Organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code; the Jesus Christ Worldwide Christian Center, Inc. Jesus Christ Worldwide Christian Center (JCWCC) states as follows:

(A). That no part of the net earnings of this corporation/organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that (JCWCC) shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. JCWCC Ministry shall not be carrying on of propaganda, or attempting to influence legislation. JCWCC shall not participate in or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

(B) JCWCC shall not carry on any other activities not permitted to be carried on by a corporation/organization exempt from Federal tax code. JCWCC will govern all contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

(C). There after, upon the dissolution of this corporation/organization-JCWCC- assets shall be distributed for one of more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.

Jesus Christ Worldwide Christian Center is hereby requesting classification as a ministry described as publicly under Sections 509 (a)(1) and 170(b)(1)(a)(VI), instead of a church.

WHEREBY, as stated above, Jesus Christ Worldwide Christian Center (JCWCC), want consideration under Section 509(a)(1) and 170(b)(1)(A)(VI) instead of church classification.


