### ARTICLES OF INCORPORATION CONTRACTION AND A SAME FURIDAL OF FELLOWSHIP OF BELIEVERS OF JACKSONVILLE, INC. A FLORIDA CORPORATION NOT FOR PROFIT

In order to form a corporation in accordance with the provisions of the laws of the State of Florida for the formation of corporations not for profit, Chapter 617, Florida Statutes, the undersigned, hereby as incorporator, designates the following articles for the purposes and with the powers hereinafter mentioned.

#### ARTICLE 1

1.01. CORPORATION NAME. The name of this corporation is:

"FELLOWSHIP OF BELIEVERS OF JACKSONVILLE, INC."

#### ARTICLE 2

2.01. TERM OF EXISTENCE. The period of the duration of the existence of this corporation will be perpetual and shall commence at the time of filing of the Articles of Incorporation by the Florida Department of State.

#### ARTICLE 3

3.01. PURPOSES AND RESTRICTIONS. The purposes of the corporation and restrictions on its operations are as follows:

(a) The corporation is organized exclusively for the purpose of organizing, maintaining and operating a Christian Church, including the promotion of the charitable, religious and educational objectives associated with the operation of a Christian Church (all of which shall be within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding provisions of any future United States Internal Revenue Laws).

(b) The corporation shall restrict its operations to the promotion of the religious, charitable, and educational purposes of a church within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as presently or hereafter existing ("Code"). Notwithstanding any provision of these Articles of Incorporation to the contrary, the corporation shall take no action inconsistent with the provisions of the Florida Not For Profit Corporation Act.

(c) No part of the net carnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

(d) To do any and all things and exercise any and all powers, rights and privileges provided herein and in the Bylaws consistent with its purposes and with the provisions of Section 501(c)(3) of the Code.

#### ARTICLE 4

4.01. REGISTERED AGENT AND PRINCIPAL OFFICE. The Registered Agent and the street address of the initial registered office and of the principal office of the corporation in the State of Florida shall be:

#### **ARTICLE 5**

5.01. MEMBERSHIP. This corporation shall be a membership organization. Membership, and the rights and duties of Members, shall be governed by the Bylaws, except that the Members shall have the right to elect the Directors.

#### **ARTICLE 6**

6.01. DIRECTORS. The powers, business and affairs of the corporation shall be managed by and directed by the Board of Directors in accordance with these Articles and the Bylaws. The number of directors may be increased or diminished from time to time by the Bylaws but there shall at all times be at least three directors. The method of electing the directors shall be as provided in the Bylaws.

#### **ARTICLE 7**

7.01. INCORPORATOR. The name and street address of the incorporator of this corporation is as follows:
