ARTICLE ONE. NAME

The name of the corporation is SPIRIT OF LIFE PENTECOSTAL HOLINESS CHURCH, INC.

ARTICLE TWO. STATEMENT OF CORPORATE NATURE

This is a non-profit corporation organized solely for general charitable purposes pursuant to the Florida Corporations Not for Profit law set forth in Part I of Chapter 617 of the Florida Statutes.

ARTICLE THREE. GENERAL AND SPECIFIC PURPOSES

The specific and primary purposes for which this corporation is (a) to invite all Pastors and their church of the apostolic faith doctrine and any other church that believes in the holy ghost, worships the name of Jesus into the corporation to mutually work in religious work such as lifting up the fallen, visiting the sick, strengthening the weak, encouraging that faint hearted, comfort the feeble mines, and by all means, point the lost to the way of salvation and to urge all believers to seek a spirit filled life (Ephesians 5:18, Act 19-16) and to prepare for the Lord Jesus (James 1:27, 1 Thess 5:14, March 16:15-18, Matthew 25:1-13); (b)

that particular field; (c) and charitable work working forward together toward the meaning to care for the indigent of it constituencies and also for the relief of the general public as the urgency of the case demand. The general purposes for which this corporation is formed are to operate exclusively for such purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code. corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; shall it participate or intervene by publication or distribution of any statements or otherwise in any political campaign on behalf of any candidate for public office.

ARTICLE FOUR. TERM

This corporation shall have a perpetual existence.

ARTICLE FIVE. MEMBERSHIP

The corporation shall have a membership distinct from the board of directors, but members of the board of directors must be members of the corporation. Membership of this corporation is (a) all, such as Pastor, Evangelist, Missionaries, Elder, Deacon, and Deaconess are members of the corporation and any lay person having a good report in the community that are in good standing in their church

are eligible to become a member; (b) if a member of the corporation become dissatisfied with his or her membership for one reason or another and does not care to remain a member any longer he may resign, return his or her church in which he came from without molestation; (c) if is should become necessary to remove a member from the membership roll of this corporation because. said removal shall be done pursuant to the bylaws. (d) the Spirit of Life Pentecostal Holiness Church will issue license certificate's for the benefit of minister's of the corporation such as credentials for ordained minister, ordained deacon general license for ordained deacons and missionary certificate for and missionaries and members. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be set forth in the bylaws.

> ARTICLE SEVEN. LOCATION OF PRINCIPAL OFFICE AND IDENTIFICATION OF REGISTERED AGENT

The County in the State of Florida where the principal office for the transaction of the business of this corporation is to be located is the 7851 Amberidge Road, Pensacola, 32534, County of Escambia.

ARTICLE EIGHT. MANAGEMENT OF CORPORATE AFFAIRS

Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted and managed by a board of directors. The number of directors of the corporation shall be not more than seven (7) and not less than two (2); provided, however, that such number may be changed by a bylaw duly adopted by the members. All members shall be 21 years or older.

Such written consent or consents shall be filed with the minutes of the proceedings of the board, and any such action by written consent shall have the same force and effect as if taken by unanimous written consent of the board of trustees without a meeting and that the articles of incorporation and bylaws of this corporation authorize the trustees to so act. Such a statement shall be prima

facie evidence of such authority.

Management of the corporate affairs and procedures shall be based upon the Apostolic Doctrine and Custom as practiced by Spirit of Life Pentecostal Holiness Church so long as said doctrine and custom are not in violation of Florida Law.

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE TWELVE. AMENDMENT OF ARTICLES

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by the vote of 3/4 of a quorum of members of the corporation.

ARTICLE THIRTEEN. INCORPORATORS
