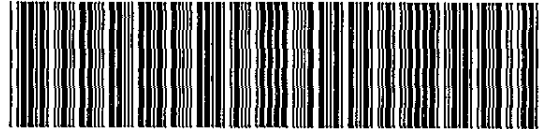

**ARTICLES OF ORGANIZATION FOR THE
RELIEF, HELP AND DEVELOPMENT FOUNDATION, INC.**

Article 1.- Name of Corporation:

Relief, Help and Development Foundation, Inc.

Article 2.- Principal place of business and mailing address of the Corporation:

Article 3 .- The specific purpose or purposes for which the corporation is organized:

The corporation is organized for the purposes of a) assisting in the relief of social, economic and medical problems of the people of the Republic of Haiti; b) working with poor villages, their leadership and the general population to improve education, health, sanitary practices and general economic well-being amongst the poor in the Republic of Haiti; and c) to encourage, fund and assist in the creation and direction of small economic development projects in the Republic of Haiti.

Article 4.- The manner by which the Directors are elected or appointed:

The Directors of the corporation are elected for a term of one year at the General Meeting of the Corporation and can be reelected indefinitely. Three Directors will serve initially.

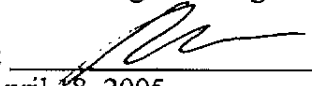
