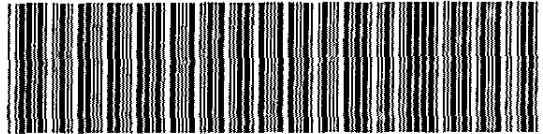

CHARTER & ARTICLES

OF INCORPORATION

FOR

THE ENDTIME MESSENGERS OUTREACH MINISTRIES INCORPORATED

In the name of Jesus, our Lord and Saviour,
We, the undersigned, do associate together to form and
establish a nonprofit coporation under the laws of the
State of Florida.

We, thereby adopt and agree to the following Ar-
ticles,

Article I

The name of the Corporation, Organization or
Church (to be used interchangeably throughout these
Articales) shall be called The Endtime Messengers Out-
reach Ministries Incorporated.

Article II

The location of our Church and Principal place
of business shall be: 1803 S.E. 6th Ave . Gainesville,
Florida 32641. Alachua County.

Article III

The specific purpose of this organization , It
is a non profit, organization, Non-denominational Minis-
try. called to preach the gospel to every living creature
man, woman, boy and girl. For God is no respecter of person.
For God so loved the world. He gave His only begotten Son,
that whosoever believeth in Him shall not perish, but have
ever lasting life."

A) We shall teach and preach love and compassion toward

one another with respect for the constiution of
the United States of America and all subdivisions
thereunder;

- B) We do safeguard and transmit to posterity the
purity and righteousness and fredom of each
individual and teaching of the Lord;
- C) We shall have Prophets, Evangelists, teachers,
Missionaries, Deacons, Tent Revivals, TV, Radio,
Counseling, Prison, Street Ministries, and Nursing
Home Ministries
- D) We shall reach out to help the community to assist
to the best interest of the order and to the society
as a whole.
- E) We shall cloth the necked, and feed the hungry.
- F) We shall raise funds for caring the same into
affect in any manner allowed by the State and
permitted under the Consitution of the United
States of America;
- G) Members will support the Church and Pastor by
the paying of Tithes and Offerings, according
to St. Luke 6:38 and Malachi 3:8-10.

Article IV

Membership is open to the public. To all who
shall come and partake to the word of God and to take
Jesus as his personal Lord and Saviour.

Article V

The duration of this organization is forever.

Article VI

The manner in which the directors are elected or appointed is that the general officers of this organization shall be the Pastor, Assistant Pastor, Deacons, Ministers, Trustees and Board Members.

A) The Pastor is the spiritual leader of the flock, whose job is to be a good , strong, faithful leader, to lead and guide the flock in the ways of the Lord.with oversight and insight in spirit and in truth, The pastor shall be elected by the Church and remain Pastor until his resignation or death.

B) The Assistant Pastor shall carry out the duties of the pastor in his or her stead, when the pastor is unable to serve. The assistant pastor is elected through the nomination of the Pastor and selected by the Church, and likewise removed.

C) Trustees shall be nominated by the spiritual insight of the Pastor, and approved by the Board to serve until they resign or removed by the pastor and and the Board in the same capacity as directors of the Corporation. If someone is moved the Trustee Board has the authority to fill that vacancy. This board also has the authority over all financial dealing including salaries of all employees of the Church). Trustees shall be responsible for the upkeep of the church,and it's financial needs i,e.

the purchase and maintance of such items as musical instruments, chairs, air conditioners.and a place of worship.

D) Deacons shall assist the Pastor or Assistant Pastor in ministering to the members of the church. They shall be loyal and Trustworthy exemplifying one full of the Holy Ghost. They can be removed by the Pastor and the Board in the same manner as the Trustees.

E) Ministers shall also assist the Pastor in witnessing for the Lord, spreading the word of God, praying for the sick.

Ministers are called by God, but can be removed for unbecoming behavior by the Board upon nomination of the Pastor.

F) Other Officers shall be elected and their duties shall be determined according to the by laws of this organization.

Article VII

The number of initial directors of this Organization who shall also be on the Board of Trustees and designated Officers of the church shall be three. The affairs of this Organization shall be conducted by the Directors, whose names and addresses are as follows:


Article VIII

the same persons listed in Article VII.


Article IX
