ARTICLES OF INCORPORATION
FLORIDA RENEWABLE RESOURCE CONSERVATION AND
DEVELOPMENT COUNCIL, Inc.

We the undersigned, natural persons of the age of twenty-one years or more, acting as incorporators, adopt the following **Articles of Incorporation** for such corporation pursuant to the Florida Statutes, Chapter 617, and the U.S. IRS Tax Code.

FIRST: The name of the Corporation is Florida Renewable Resource Conservation and Development Council, Inc.

SECOND: The principal place of business is 21158 SW 2nd Avenue, Newberry, Florida. The mailing address of the corporation and of its initial registered agent, Thomas V. Cunilio, is 3953 N.W. 27th Lane, Gainesville, FL 32606

THIRD: The purposes for which this corporation is organized are exclusively charitable, technical, scientific and vocationally educational and consist of the following: to conserve and develop natural resources including natural human resources in and around the state of Florida with special focus upon **renewable energy project development** for a multi-county area of counties to include but not be limited to Alachua, Bradford, Citrus, Marion and Union Counties. A focus of resource conservation and development in areas other than renewable energy will be made wherever and whenever practicable.

FOURTH: Directors are elected according to the By-laws written and approved by the Steering Committee in March, 2005, Don M. Post, Chairman.

FIFTH: The number of Directors constituting the initial Board of Directors is nine (9) and the names and addresses, including street and number of the persons who are to serve as the initial directors until the first annual meeting or until their successors be elected and qualified are:

John Chamberlain 8620 NW 13th St., Gainesville, FL 32653
Steve Lowrimore 623 NE 2nd St., Williston, FL 32696
Thomas Cunilio 3953 NW 27th Lane, Gainesville, FL 32606

SIXTH: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay and to make reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation

shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any political candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from the Federal Income tax under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law or (b) by a Corporation contributions which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal revenue law.).

SEVENTH: Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, economic development, religious or scientific purposes as shall at the time qualify as an exempt organization or organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the court in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.

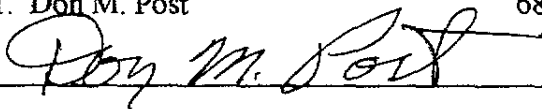
