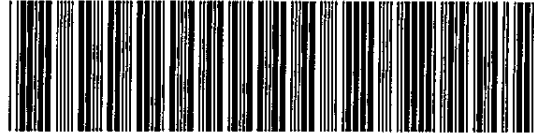

Pursuant to the provisions of Section 617, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Incorporation, which were adopted by the Board of Directors and do not require member approval.

**ARTICLE 1 - NAME**

The name of the corporation shall be: EXECUTIVE SINGLES, INC.

**ARTICLE II - PRINCIPAL OFFICE**

**ARTICLE III - PURPOSES**

The specific purposes for which the corporation is organized are:
