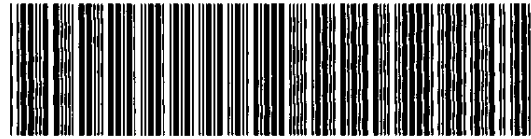

THE LIFE-TAMPA, INC.

AMENDMENT OF ARTICLES OF INCORPORATION

PREAMBLE

For the more certain preservation of the principles of our faith, and to the end that this body may be governed in an orderly manner, and for the purpose of preserving freedom of action of this body with respect to its relation to other churches, to its own members, and to its task of reaching the world with the gospel of Jesus Christ, we do declare and establish this constitution.

ARTICLE I NAME

This church shall be known as THE LIFE-TAMPA, INC. (hereinafter sometimes referred to as the "church").

ARTICLE II PURPOSES AND LIMITATIONS

SECTION 1- Purposes

The Life-Tampa, Inc. is organized and shall be operated exclusively for religious, charitable, and educational purposes within of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. More particularly, believing in the Bible as the inspired Word of God and as the authority for faith and practice, and acknowledging its commitment to all of the teachings of Jesus Christ. The LIFE-TAMPA declares its purpose:

To lead people into a growing relationship with Jesus Christ

SECTION 2- Limitations

In order to carry out the above-stated purposes, the Church shall have all those powers set forth in Florida Not For Profit Corporation Act, as it now exists or as it may hereafter be amended. The powers of the church to promote the purposes set out above are limited and restricted in the following manner:

- a. No part of the net earnings of the church shall inure to the benefit of or be distributable to its incorporators, officers or other private persons, except that the Church shall be authorized and empowered to make payments and distributions (including reasonable compensation for services rendered to or for the Church or reimbursement of expenditures) in furtherance of its purposes as set forth in these Articles. No substantial part of the activities of the Church shall be the carrying on of Propaganda, or otherwise attempting to influence legislation, and the Church shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the Church shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

- b. The Church shall not accept any gift or grant if the gift or grant contains major conditions which would restrict or violate any of the Church's religious, charitable, or educational purposes or if the gift or grant would require serving a private as opposed to a public interest.
- c. Upon the liquidation, dissolution or winding up of the Church, the Board of Directors of the Church shall, after paying or making provision for payment of all the liabilities of the Church, distribute all Church assets to any organization designated by the Board of Directors of the Church which is of like faith and order and is exempt from taxes under Internal Revenue Code Section 501(c)(3) (or the corresponding provision of any future tax law of the United States).

ARTICLE III - ARTICLE OF FAITH

The Life-Tampa, Inc. adopts the DOCTRINE OF THE LIFE TAMPA, revised September 1, 2009
The following are the basic outline of the Statement of Faith of The Life-Tampa, Inc.:

Statement of Faith

- i. God is sovereign in all His ways.
- ii. God is one, yet manifested in three persons: Father, Son and Holy Spirit.
- iii. God redeems mankind through a blood covenant with His Son, Jesus. Those who embrace the covenant are saved from this present evil age.
- iv. God and Jesus give the Holy Spirit to convict the sinner and empower the righteous.
- v. God calls His church to establish His kingdom on earth.
- vi. God resurrects the righteous believers who die.
- vii. God will literally send His Son, Jesus to execute judgment on the unbelievers. Those who believe will live with Him forever.

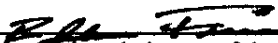
