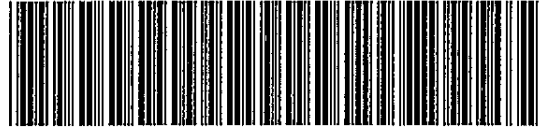



Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

1. NEW CORPORATE NAME:

Early Learning Coalition of Florida's Gateway, Inc.

2. AMENDMENTS ADOPTED:

Article IV – Purpose. In the first paragraph ending with the word, “success”, the following phrase is added: *“in accordance with Florida’s Voluntary Prekindergarten Education Program and School Readiness Act”*.

The amended paragraph shall reflect as follows:

The specific purpose for which the corporation is organized is for the purpose of providing opportunities for the at-risk birth to kindergarten population to enhance their chances for educational success in accordance with Florida’s Voluntary Prekindergarten Education Program and School Readiness Act.


