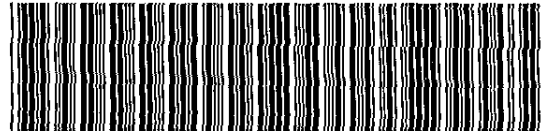

ARTICLES OF INCORPORATION

We, the undersigned, desiring to form a corporation not for profit, namely, Grand Chapter Royal Arch Masons of Florida Everglades Chapter 67, Inc. under the provisions of Chapter 617, Acts of the Legislature of the State of Florida, and all acts amendatory thereto, hereby make, subscribe and file with the Secretary of State, of the State of Florida, a proposed charter as follows;

I

The name of the corporation shall be Grand Chapter Royal Arch Masons of Florida Everglades Chapter 67, Inc. which shall be located at 5850 North Tamiami Trail, Naples, in Collier County, State of Florida.

II

The general nature and objects of this club shall be;

To give primacy to the human and spiritual, rather than to the material values of life.

To encourage the daily living of the Golden Rule in all human relationships.

To promote the adoption and application of higher social business, and professional standards.

To develop, by precept and example, a more intelligent, aggressive and serviceable citizenship.

To provide, through the club, a practical means to form enduring friendships, to render altruistic services, and to build a better community.

To cooperate in creating and maintaining that sound public opinion and high idealism which makes possible the increase of righteousness, justice, patriotism, and good will.

Further, the purposes for which the Grand Chapter Royal Arch Masons of Florida Everglades Chapter 67, Inc. is organized is exclusively religious, charitable, scientific and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

III

The active membership of this club shall consist of men of good character and community standing, residing, having community interested in, or engaged in recognized lines of business, agricultural, institutional, and professional life, within the territorial limits of the club.

The further qualifications of members and the manner of their admission shall be governed by the By-Laws.

No part of the new earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any further United States Internal Revenue law. On the dissolution of this corporation, the Board of Directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable,

educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determined are organized and operated exclusively for charitable, education, religious or scientific purposes.

This corporation not for profit shall have perpetual existence.

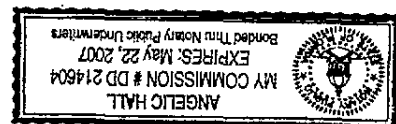




