

Please find enclosed the appropriate forms for incorporation in the state of Florida as a not-for-profit organization. We wish to draw to your attention that the incorporation name is the same as the as the incorporation name currently being voluntarily dissolved. These concurrent actions are being taken due to an oversight when the original incorporation papers were filed on February 27, 2004 under document number P04000038580 at which time resulted in the creation of a for-profit incorporation structure. We never intended to form a for-profit corporation and therefore, we do not wish to reinstate. By voluntarily dissolving the original for-profit incorporation and forming a new, not-for-profit incorporation we seek to maintain our original "identity" while altering our legal status to a not-for-profit incorporation. We release the "Pirate Band Patrons Association, Inc." legal name to our new, not-for-profit incorporation.

Article I

The name of the Florida Not-For-Profit Corporation shall be:

The purpose for which the corporation is organized is:

Article IV
