#### ARTICLES OF INCORPORATION

#### BOCA PLACE CONDOMINIUM ASSOCIATION, INC.

(a Florida corporation not for profit)

We, the undersigned, hereby acknowledge and file in the Office of the Secretary of State of Florida, for the purpose of forming a corporation not for profit under the Laws of the State of Florida, these Articles of Incorporation as provided by law.

#### ARTICLE ! <u>NAME</u>

The name of this corporation is BOCA PLACE CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall hereinafter be referred to as the "Association".

#### ARTICLE II -**PURPOSES AND POWERS**

The purposes for which this corporation is formed are as follows:

To be the "Association" as defined in the Condominium Act (Chapter 718 Section 1. Florida Statutes) of the Statutes of the State of Florida, and as such to established and collect assessments from the unit owners and the members for the purpose of operating, maintaining, preparing, improving, reconstructing and administering the Condominium Property.

To carry out the duties and obligations and receive the benefits given the Section 2. ASSOCIATION:

For any lawful purpose. To accomplish the foregoing purposes, the corporation Section 5. shall have all corporate powers permitted under Florida law, including, but not limited to, the capacity to contract, bring suit and be sued, and those provided by the Condominium Act.

#### ARTICLE III **MEMBERS**

The members of the ASSOCIATION shall consist of the record owners of Section I. residential Condominium Parcels within BOCA PLACE CONDOMINIUM, (hereinafter referred to as "CONDOMINIUM"). Provided, however, that pursuant to the DECLARATION, the approval of the ASSOCIATION must be obtained prior to becoming a member. After receiving such approval as may be required under the DECLARATION, change of membership to the ASSOCIATON shall be established by recording in the Public Records of the County in which the Condominium is located a Deed or other instrument establishing record title to the Condominium Parcel and the delivery to the Association of a copy of such instrument. Such membership shall automatically terminate when such person is no longer the owner of a Condominium Parcel. Membership certificates are not required and shall need not be issued.

On all matters upon which the membership shall be entitled to vote, there shall be only one (1) vote for each Unit, which vote shall be exercised by the Unit Owner in accordance with the provisions of the DECLARATION and By-laws. Until the Condominium Property is formally submitted to condominium dwnership, the membership of the ASSOCIATION shall be comprised of the Developer of the CONDOMINIUM, its successors, grantees and assigns. Wher the Condominium Property is formally submitted to condominium ownership, the Developer shall exercise the membership rights of a Unit until title to the Unit is transferred, unless expressly otherwise provided herein or in the By-laws.

- The shares of a member in the funds and assets of the ASSOCIATION cannot Section 2. be assigned, apothecated or transferred in any manner except as an appurtenance to a unit.
- Subject to the foregoing, admission to and termination of membership shall be Section 3. governed by the DECLARATION.

#### <u>ARTICLE IV</u> EXISTENCE

The corporation shall have perpetual existence.

#### ARTICLE VI DIRECTORS

- Section 1. The affairs of the corporation shall be managed and governed by a Board of Directors composed of not less than three (3) nor more than nine (9) persons. The first Board of Directors shall have three (3), and in the future, the number will be determined from time to time in accordance with the provisions of the By-laws of the corporation.
- Section 2. Directors shall be elected by the voting members in accordance with the By-laws at the regular annual meeting of the membership of the corporation or at any special meeting called for the purpose of electing one (1) or more Unit Owners other than the Developer in accordance with the DECLARATION and the By-laws. Directors shall be elected to serve for a term of one (1) year, or in the event a Director is elected at any meeting the purpose of which to elect a Unit Owner other than Developer to serve as a Director until the next annual meeting of the membership. In the event of a vacancy, the elected Directors may appoint an additional Director to serve for the balance of said term.
- Section 3. All officers shall be elected by the Board of Directors in accordance with the By-laws. The Board of Directors shall elect form among the members a President, Vice-President, Treasurer and Secretary and such other officers as shall be elected from among the membership of the Board of Directors, but no officer need be a Director.

### ARTICLE VII OFFICERS, INITIAL OFFICE AND REGISTERED AGENT

Subject to the direction of the Board of Directors, the affairs of the ASSOCIATION shall be administered by the officers who shall serve at the pleasure of the Board of Directors. Notwithstanding the foregoing provisions of this Articles X, no amendment to these Articles shall abridge, amend or alter the rights of the Developer of may be adopted or become effective without the proper written consent of the Developer.

Any voting member may waive any or all of the requirements of this Article as to notice by the Secretary or proposals to the President for alteration, amendment or rescission of these Articles, either before, at or after a membership meeting at which a vote is taken to amend, alter or rescind these Articles in whole or in part.

#### ARTICLE XI INDEMNIFICATION

Every officer and every Director of the ASSOCIATION shall be indemnified by the ASSOCIATION against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding or any settlement thereof, to which he may be a part, or in which he may become involved, by reason of his being or having been a Director or officer of the ASSOCIATION, whether or not he is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties; provided that in the event of a settlement, the indemnification herein
