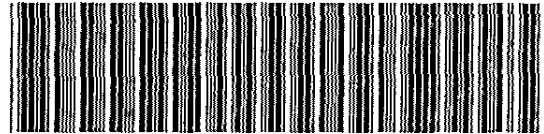

*Articles of Incorporation pursuant to chapter 617,FS Florida Statutes reading as follows:*

**Article I:**

*The Name of the Corporation Is The Haitian Arts Foundation Inc."*

**Article II:**

**Article III:**

*Purpose of the Foundation is to: to establish Programs"; such as promotion and education, of the Haitian youth residing in Haiti and/or in State of Florida people hereinafter referred to as "ARTIST(s)" member of the immigrant and or minority or low to moderated income community at large. The Foundation will procure and develop Art of education for the benefit of underprivileged children, and poor parents preceding from the third world especially Haiti, Caribbean and the Virgin Islands*

*The program consist on establishing programs aiming to serve members of the Haitian and other minority community residents of Florida:*

- I. A. Promulgating the Haitian Arts through Art Exhibits and Shows in the United States**
- II. B. Providing fine art education for those in need to prepare themselves to develop their attitude in the fields of Fine Arts, and Art Crafts, advertisements or ad campaign. Promoting Haitian Artists in areas such as Canvas Art painters, in prints or on screen, books magazines, newspapers, television commercials, posters, films and video or on the World wide Web.**
- III. C. Providing scholarship for students needing Pre and post Secondary education vocational and technical training and continuing education in the Art.**

*Other purposes:*

*1) To provide, education, training, Higher Education and support to individuals, organizations and members any groups or subgroups of the State of Florida minority community help them form, create and implement programs aiming to help the individuals and organizations. To provide charitable, education or philanthropic activities with the purpose to improve the standard of living for Haitians, Caribbean and/or indigenous communities as well any other*

2) To have and exercise all the powers necessary or convenient to effect the objects for which it is formed, and in general to have and exercise all powers conferred by the State of Florida upon corporations created under Florida law as they may be or are hereafter amended. The foregoing enumeration of the objectives, purposes and powers of the organization is not intended to, and does not prohibit or limit the exercise of any other further rights or powers which may not or hereafter be allowed or permitted by law to the organization, provided, however, that all gifts and bequests to the organization, and the net earnings and assets of the corporation shall be used in the United States of America and/or Haiti for the charitable and educational purposes for which it was formed.

### **c.-Section 1 - Operational Statement**

All affairs of this corporation shall be administrated by the Corporation Board of Directors,, being them the officers of this corporation

Notwithstanding any other provision hereof, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under 501(c) 3 of the Internal Revenue Code and its regulation as they may now exist or as they may hereafter be amended.

There will be no voting by proxy, voting shall be viva voice. Each member shall be entitled to vote only in person at each regular or special meeting of the Board
