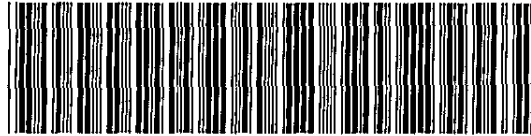

**ARTICLE I:** The name of the cooperation shall be, Bartow Low Power FM, Inc.

**ARTICLE II:** The principal place of doing business shall be 1245 West McLeod Street, Bartow, Florida.

**ARTICLE III:** The Purpose of Bartow Low Power FM, Inc. shall be:

- (1) To provide an outlet for public service broadcasting by government, civic associations, charitable and other non-profit organizations.
- (2) To provide educational broadcasting opportunities for school sponsored athletic and other programs which would not be covered by the broadcast media in the in the area.
- (3) To provide affordable broadcasting opportunity for the worship services of religious organizations in the Bartow area.
- (4) To provide educational information on the technical aspects of radio broadcasting for students in schools and other interested persons.
- (5) To provide an introduction to working in broadcasting for students and other persons interested in careers in this area. This also applies to Amateur Radio (Ham) classes.
- (6) To work closely with the Polk County Historical Museum and county historical groups to further educate the local citizens as to the rich history of the county.
- (7) To provide programs and newsto meet the listening interest of persons who otherwise no other sources for their programming interest.
- (8) If requested to assist, to provide emergency notices and shelter information in times of local emergency or natural disasters.
- (9) To educate the local listeners with new laws and environmental issues that have or will go into laws that will effect them.

**ARTICLE IV:**The directors shall be elected at the annual meeting to take place on the second Tuesday in January of each calendar year, ten (10) days in advance by registered mail.
