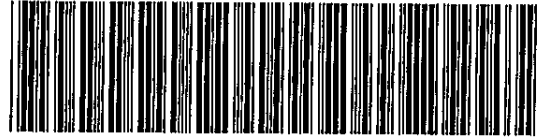

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation.

ARTICLE I

The name of the corporation shall be:

The principal place of business of this corporation shall be:

ARTICLE II

The period of duration of this corporation is perpetual or forever unless dissolved according to law.

ARTICLE III

The purpose for which the corporation is organized is:

to serve for a clearing house of information of a religious and religious educational nature, to provide a means of education for prospective ministers and to be a vehicle for ordination of such proposed ministers and, in general, to assist independent churches in the organization, administration and management of their affairs when such churches choose to become members of the organization.

The basic religious beliefs of the United Christian Center for Abundant Living, Inc., are based upon the teachings of Jesus Christ. We believe that the principles he taught and demonstrated while on earth were set forth as a guide for all future generations. And, believing this we are committed to expound and to explore these teachings through study classes. These study classes are designed to teach people and acquaint them with these principles so that they may know the truth about themselves and God, and thereby exercise them in their daily living.

ARTICLE IV

The qualifications for members and the manner of their admission are:

the membership requirements are that a prospective member church wishing to apply for membership in the organization must file a written request, accompanied by a resolution from the Governing Board of said Church, a copy of its financial report and evidence that the applicant church is a tax-exempt organization under the Florida Revenue Code.

ARTICLE V
