**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
OF CATHEDRAL KIDS LEARNING CENTER, INC.**

Pursuant to the provisions of Section 617.1001, 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, CATHEDRAL KIDS LEARNING CENTER, INC., a not for profit corporation organized and existing under the laws of the State of Florida, hereby amends its Articles of Incorporation as follows:

**FIRST:** The name of the corporation is Cathedral Kids Learning Center, Inc. (the Corporation").

**SECOND:** The following amendment to the Articles of Incorporation was adopted by the Corporation:

Article I is hereby amended to read as follows:

**"ARTICLE I**  
**Name**

The name of the corporation is the MESSIAH CHRISTIAN ACADEMY, INC. (the "Corporation")."

**THIRD:** The Amendment was adopted by the Board of Directors on July 19, 2006 by a resolution setting forth the proposed amendment and was approved by the sole member of the Corporation on July 19, 2006, the number of votes being sufficient for approval.
