#### ARTICLES OF INCORPORATION FOR ASIAN NEIGHBORHOOD FAMILY CENTER, INC.

#### ARTICLE I NAME/REGISTERED OFFICE

The name of the Corporation shall be: Asian Neighborhood Family Center, Inc.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1801 62<sup>nd</sup> Avenue North, St. Petersburg, Florida 33702.

#### ARTICLE III PURPOSE
