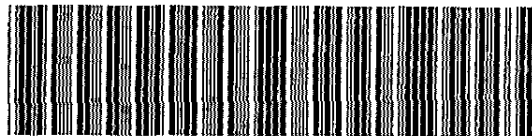

FOR

**ARTICLE I  
NAME/REGISTERED OFFICE**

The name of the Corporation shall be: Asian Neighborhood Family Center, Inc.

**ARTICLE II
