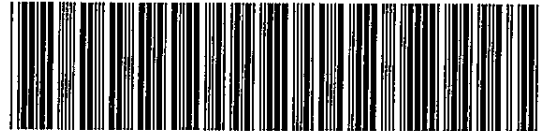



I. CORPORATE NAME The name of the corporation is:


