Attachment to Articles of Incorporation of SweetSmart Foundation, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is Sweetsmart is an organization for the "street smart" diabetic child. It provides practical help, support by other diabetic children and their families, while offering monetary support to families not eligible otherwise for monies for diabetic camps, supplies, education, and all other aspects of living with this disease.
