## ARTICLES OF INCORPORATION OF THE AMERICAN QUR'ANIC WORKS ASSOCIATION, INC. a Florida not-for-profit corporation

In Compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I NAME

The name of the corporation shall be: The American Qur'anic Works Association, Inc., a Florida not-for-profit corporation.

#### <u>ARTICLE II</u> <u>PRINCIPAL OFFICE</u>

The principal place of business and mailing address of this corporation shall be: 2987 Vineland Road, Kissimmee, Florida 34746

#### ARTICLE III PURPOSE

The purpose for which the corporation is organized is: to empower individuals, families, and communities to achieve and maintain self-sufficiency through an integrated program of social, educational, and advocacy services.

#### ARTICLE IV BY-LAWS

The Directors here-in-after named shall create by-laws for this not-for-profit entity at their first meeting, which shall be held within sixty (60) days after execution of these Articles of Incorporation. Said by-laws will provide for a membership meeting every other year and define the qualifications for membership. Provided, however, that the qualifications for membership shall never exceed a commitment to and tangible support for the purposes of this not-for-profit corporation.

#### ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected or appointed: The initial directors shall provide for by-laws whereby there shall be no less than six (6) director. No less than two (2) directors shall be elected by the directors each year to serve terms of three (3) years each. Not less than one director shall be black, not less than one director shall be white, not less than one director shall be Hispanic, not less than one director shall be a Muslim, not less than one director shall be a Christian, not less than one director shall be under the age of thirty, not less than one director shall be over the age of sixty, not less than one director shall be male, and not less than one director shall be female.
