

# ARTICLES OF INCORPORATION OF SECRETOWN FLA., INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit corporation.

### ARTICLE I
