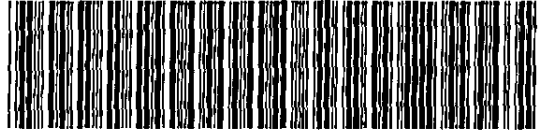

ARTICLE I - NAME

The name of the corporation shall be:

New Birth Missionary Baptist Church of Orlando, Florida Incorporated

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III- PURPOSE

The purpose for which the corporation is organized is to give a visible form of faith and fellowship to which God has called his people.

7. To be zealous in our efforts for Christ (Titus 2:14)

3. To aid in sickness and distress (Gal. 6:2; James 2:14-17)
4. To cultivate sympathy and courtesy (1 Peter 3:8)
5. To be slow to take offense, but always ready for reconciliation (Eph. 4:30-32)
