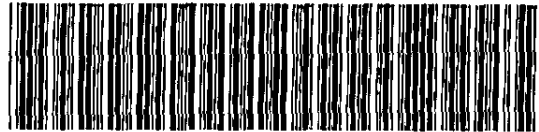

**Articles of Incorporation**

Article I Name of Corporation  
Randall Tracy Ministries , Inc.

Article II Place of business and mailing address  
10738 Grayson Street

Article III Purposes for which the corporation is organized ;

Religious

1. To disseminate The Gospel of Jesus Christ locally and worldwide.
2. To, for, and with individuals that they may know their place in the Body of Christ.
3. To pray for the sick, to counsel and pray with those who have personal problems.
4. To lead praise and worship with musical instruments / equipment in indoor and outdoor assemblies.
5. To provide New Testament doctrine for salvation, discipleship, and instruction in righteousness.
6. To act with charitable concern for, to help carry on, and to support programs of social action for poor, widowed, orphaned, afflicted, imprisoned, underprivileged, aged persons, or homeless persons regardless of race or religious affiliation.
7. To baptize with water, anoint the sick with oil, to pray with others to receive the Baptism of The Holy Spirit with the evidence of speaking in tongues.
8. To disseminate The Gospel message through, but not limited to, radio, printed publications, media, recordings, internet, television, and other modern methods of publicity or proclamation.
9. To promote and encourage through ministry of the organization cooperation with other organizations in the Christian ministering community.
10. To acquire and hold properties both real and personal for the ministry organization, as may be necessary for the proclamation of the Gospel .

Article IV Director Appointment

A. Director Appointment shall be by the President and the Vice- President concurrently.

Article V Organizational Powers

A. The property of this non-profit organization is irrevocably dedicated to Christian charitable purposes. This non-profit corporation is not organized for pecuniary gain or profit, nor shall it have any power to issue certificates of stock or declare dividends, and no part of its' net earnings shall inure to the benefit of any members, directors, trustees, or individuals, except that the corporation shall be authorized and empowered to pay a reasonable compensation for expenditures and services actually rendered, and make payments and distributions in

accomplishing the purposes set forth in Article III hereof.

B. This organization shall not carry on any activities not permitted by Section 501(c) (3) of the Internal Revenue Code of 1954, or Section 170 (c) (2) of the Internal Revenue Code of 1954.

C. No substantial part of the activities shall be the carrying on of propaganda or otherwise attempting to influence legislation. And this corporation shall not participate in , or intervene in a political campaign.

D. The membership in this corporation is non-transferable and terminated by death, accepted letter of resignation, or dissolution of the corporation only.

E. In case of dissolution of the corporation or termination of membership, no member shall have any right to properties real or personal. Properties must be donated to an acceptable Christian non-profit organization determined by the concurrence of the President and Vice President. In case of survivorship this determination would be made by Director # 1, in accordance with the aforementioned Christian non-profit status of the receiving organization.

F. The Officers are as follows: President Randall Tracy, Vice President Gale Tracy, Director # 1 Marion Williams

G. This organization will not be subordinate to, or subject to the authority of any national association, foundation, corporation, society organization, or non-profit organization.
