

ARTICLES OF INCORPORATION

NUEVO AMANECER MUSIC AND RECORDING MINISTRY, INC. (Florida Non-Profit Corporation)

THE UNDERSIGNED, each with the capacity to contract, hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the state of Florida.

THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I. NAME

The name of this corporation shall be: Nuevo Amanecer Music and Recording Ministry, Inc.

THE ADDRESS OF THE MINISTRY: The principal address of the ministry is: 145 East 7th Street, Hialeah, FL 33010

THE MINISTRY MAILING ADDRESS: The mailing address of the ministry is: 102 West 7th Street, Suite #9, Hialeah, FL 33010

ARTICLE 2, PURPOSE

The specific purpose for which the corporation is initially organized is to ENGAGE IN THE GOSPEL MUSIC MINISTRY, IN THE UNITED STATES AND AROUND THE WORLD. TO PRODUCE AND DISTRIBUTE RECORDED GOSPEL MUSIC, AND TO SUPPORT THE WORK AND MISSION OF MMANOS, INCORPORTED AROUND THE WORLD.

to also engage in activities which are necessary, suitable or convenient for the accomplishment

of that purpose, or which are incidental thereto or connected therewith which are consistent with

Section 501(c)(3) of the Internal Revenue Code. This corporation is organized and operated

exclusively for religious purposes within the meaning of Section 501(c)(3), Internal Revenue

Code.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by (i) a corporation exempt from federal

income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding

provision of any future United States Internal Revenue law, or (ii) a corporation, contributions to

which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other

corresponding provision of any future United States Internal Revenue law. The purposes for

which this corporation is organized are exclusively religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE III

QUALIFICATION OF MEMBERS AND MANNER OF ADMISSION

Nuevo Amanecer Misic and Recording ministry will open to musicians who share the vision spreading the good tidings thru gospel music.

ARTICLE IV. TERM

The date of commencement of corporate existence shall be when these Articles have been filed with the Department of State and approved by it and the respective filing fee has been paid; the term for which the corporation is to exist shall be perpetual. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3)Internal Revenue Code. In the event of dissolution of the corporation, no part of the corporation's earning, savings, or assets shall inure to the benefit of any of its members; the residual assets of the corporation shall go (MMANOS,Inc) Mision Mundial Adventista Para Niños Olvidados, Inc.which is a tax exempt organization as described in Section 501(c) (3) and 170(c) (2) of the Internal Revenue Code of 1986, or corresponding sections of any prior or future law.

ARTICLE V. NON PROFIT ORGANIZATION

No part of the net earning of the church shall ever inure to the benefit of, or be distributable to its members, or other persons, except that the ministry shall be authorized and empowered to pay reasonable for services rendered and to make payments and distribution in furtherance of the purposes set forth in article 2.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carried on any other activities not permitted to be carried on: (a) by any corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contribution to which are tax deductible under Section 170(c) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws.

ARTICLE VI . INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII. NUEVO AMANECER BOARD

The governing board OF Nuevo Amanecer, shall consist of no less than (3) members or as determined by the ministry bylaws. The members of the governing board of the ministry shall be elected in the annual meeting in the manner set forth by the ministry bylaws. Board members maybe removed and the vacancies shall be filled in the manner provided by the ministry bylaws.

Except for the president, the officers named in these articles shall serve as officers for the ensuing year, or until the first annual meeting of the corporation, at which time they may be reelected, or replaced in the manner set forth in the ministry bylaws. The president of the church will manage the affairs of the corporation.

ARTICLE IX. BYLAWS

The first bylaws of the corporation shall be adopted by the Nuevo Amanecer board and may be amended, altered or rescinded by the board in the manner provided by such bylaws.

ARTICLE X AMENDMENTS TOARTICLES OF INCORPORATION

These articles of incorporation may be amended in the manner provides by statute or in the following manner:

Every amendment shall be approved by the board of Nuevo Amanecer Music and Recording Ministry
