FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION

OF THE CHARITABLE FOUNDATION OF ST. PETERS EPISCOPAL

CHURCH, FERNANDINA BEACH, FLORIDA, INC.

Be it remembered that the following Amendments to the Articles of Incorporation of the Charitable Foundation of St. Peters Episcopal Church, Fernandina Beach, Florida, Inc., were adopted by the members at a regular meeting after notice and provision of the Amendments to the members at least ten days prior to the meeting at which the Amendments were to be considered:

- 1. The name and address for the Registered Agent shall be amended to
 - a. Name: Joseph Woodfin, Rector
 - b. Address: 801 Atlantic Ave.

Fernandina Beach, Florida 32034

2. The provisions under ARTICLE III-MEMBERSHIP, Section 1: Eligibility, shall be deleted and the following substituted in lieu thereof:

"There shall be one class of membership.

Membership shall consist only of those individuals holding the positions of Rector, Senior Warden, or members of the Vestry of St. Peters Episcopal Church, Fernandina Beach, Florida (qualifying office)."

- 3. The caption of the paragraph entitled "ARTICLE XIII-PROHIBITED ACTIVITIES" shall be amended to read "ARTICLE XII-PROHIBITED ACTIVITIES".
- 4. The provisions under ARTICLE XIII-DEDICATION OF ASSETS shall be deleted and the following substituted in lieu thereof:

"The Foundation dedicates all assets which it may acquire to the charitable purpose set forth in Article II hereof. In the event that the Foundation shall dissolve or otherwise terminates its corporate existence, subject to the provisions of Chapters 607 and 617, Florida Statutes, the Foundation shall distribute all its remaining assets to St. Peter's Episcopal Church, Fernandina Beach, Florida, or its successor."
