**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation not for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**Name of Corporation**

The name of the corporation is Lady Cavaliers Volleyball, Inc.

**ARTICLE II**

**Place of Business and Mailing Address**

The initial principal place of business and mailing address of the corporation is 2512 Abaco Avenue, Miami, Florida 33133

**ARTICLE III**

**Nature of Business**

This corporation is organized for the sole purpose of fostering and supporting the Coral Gables High School girls volleyball team with the specific intent to limit its purpose in order to qualify for the exemption provided under Internal Revenue Code 501 (c) (3). 
