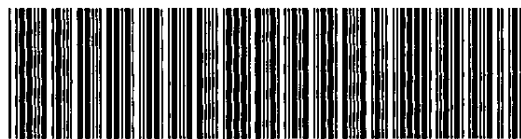

Pursuant to the provisions of Section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation:

ARTICLE III is amended to read as follows:

**The corporation is organized exclusively for charitable religious, educational, and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.**

The date of adoption of this amendment was October 11, 2010.

The amendment was adopted by the unanimous vote of the board of directors. There are no members/shareholders entitled to vote on the amendment.
