ARTICLES OF INCORPORATION OF

ONE:

The name of the corporation is WORLD INTERNATIONAL REVIVAL CENTER, B The principal place of business and mailing address of the corporation is 103 Elm Street Pensacola, Florida 32506. The corporation is organized pursuant to the Florida, Nonprofit Corporation Code.

TWO:

This religious corporation is a church or church controlled organization authorized to transact business, no one may have it's name or same name, it can sue, borrow, file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust. In accordance to the 1st Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities.
