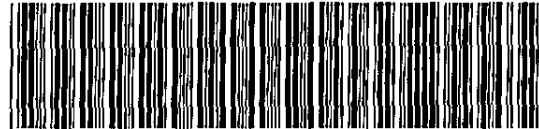

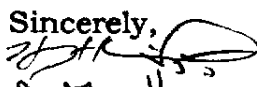

ARTICLES OF INCORPORATION

OF

Bondage Breakers, Inc.
a Non-Profit Florida Corporation

(Pursuant to Chapter 617, Florida Statutes.)

The undersigned has, for the purpose of forming a non-profit corporation under the laws of Florida, adopted the following Articles of Incorporation.

1. **Name.** The name of this corporation is Bondage Breakers, Inc..
2. **Tax-Exempt Status.** The tax exempt purposes of this corporation shall be to receive and maintain contributions of cash, real, and/or personal property to use and apply exclusively for religious purposes, either directly or by contributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code and its regulations as they now exist or any may hereafter be amended. Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by organizations described in §501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.
3. **Principal Office of Business.** The principal place of business and mailing address of the corporation is:

4. **Specific Purpose.** The specific purpose of the non-profit corporation is:

The specific purpose of this corporation is to share the gospel of Jesus Christ with those in need.
5. **Earnings of the Corporation.** No part of the earnings of the corporation shall inure to the benefit of or be distributable to its directors, officers, trustees, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in these articles.
6. **Dissolution.** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of §501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

7. **Manner of Election.** The manner in which the directors are elected or appointed is:

Any change to the Initial Members of the Board of Directors will be determined by a two-thirds majority vote by the Board of Directors.

8. **Board of Directors.** The number of directors of the corporation shall be fixed and may not be altered at anytime.

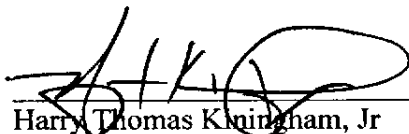

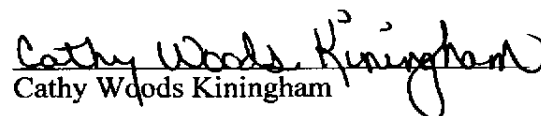

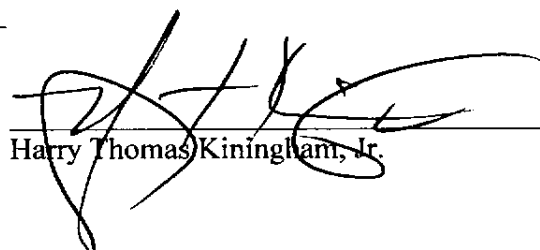
