ARTICLES OF INCORPORATION OF IAC CHAPTER 37, INC.

A FLORIDA NONPROFIT CORPORATION

ARTICLE ONE

Name

The name of the Corporation is IAC CHAPTER 37, INC.

ARTICLE TWO

Principal Office and Address

The address of the principal office of the corporation is: 1225 S.W. 87th Ave. Miami, Florida 33174, and the mailing address of the corporation is: P.O. Box 16-2323, Miami, Florida 33116

ARTICLE THREE

Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE FOUR

Purpose

(1) The purposes for which the Corporation is organized are for the active promotion, education, safety and furtherance any of aerobatic flying, competition, participation and aviation education and safety.

And

(2) Generally to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

ARTICLE FIVE

Directors

The directors of the Corporation shall be elected on a biannual basis and the manner of their election are set forth in the By-laws.

ARTICLE SIX

Registered Office and Agent

The initial registered office of the Corporation shall be located at 1225 S.W. 87th Ave., Miami, Florida 33174. The initial registered agent of the Corporation at that address shall be ROBERT WAYNE ESQ.
