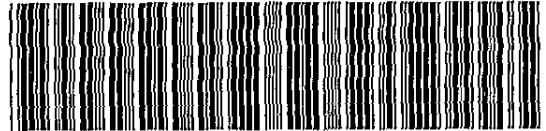

**ARTICLES OF INCORPORATION  
OF  
REVELATIONS, RESEARCH AND ENLIGHTENMENT GROUP, INC.,**

In compliance with the laws of the State of Florida, the undersigned do hereby voluntarily associate for the purpose of forming a corporation not-for-profit for the purposes and with powers set forth herein.

**ARTICLE I - NAME**

**REVELATIONS, RESEARCH AND ENLIGHTENMENT GROUP, INC.,**  
hereinafter referred to as the "**Corporation.**"

**ARTICLE II - REGISTERED AGENT**

The name and address of the Registered Agent of the Association and the Principal office address are :

**ARTICLE III - PRINCIPAL OFFICE**

The principal office of the Corporation shall be in Putnam County, Florida; but the Corporation may maintain offices and transact business in any other county in the State of Florida, as may from time to time be designated by the Board of Directors.

**ARTICLE IV - PURPOSE AND POWERS**

The purposes of which this Corporation is formed are exclusively charitable, educational, social and economic. **This organization is organized exclusively for charitable purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.** And will consist of the following:  
Literary scientific

A.

To provide Accurate, Specific Knowledge and Information through the utilization of Individual Think Tank Systems that will be Resource Centers for the entire Community and Family but set in different forums and are designed to satisfy any Quest on any Topic or subject raised by the Expansive Thought Processes.

To provide systematic educational programs that will reveal the hidden obstacles retarding Spiritual Growth that creates confusion and disunity. Said Programs will focus on Unity and Obedience to the Moral and Divine Rules for living, fostering Honesty and Unselfishness. To lift the Veil of Mystery, false and vague doctrines philosophies and theories, and to disentangle the interlaced ambiguities of Human existence.

To address every claim of the major issues of Individual Rights, Fear, Limitation Opportunity and similar ones with the hope of creating a bond of unity that transcends immediate family and age restrictions and to impart compassion, inspiration, new ideas and a true sense of Spiritual Worth.

To creating a Forum for an exchange of ideas that also considers issues affecting Youth and Young Adults Nationally and Internationally. This approach will have a tremendous impact on issues of Purpose, Morality, Crime, and Harmful Influences like hatred and indifference Resource Development and other Values profitable to mankind and Harmonious Existence

To design and implement strategies that enhance the proper development of Moral and Spiritual values and provide a sense of community that encourages a natural exchange of good ideas that produce the Peace of Mind that will keep the youthful mind industrious and keen, and ever aware that every Word, Thought and Deed have a set standard of genuine concern for Humanity.

To design and implement Consumer Credit, Financial Counseling and Basic Consumer information to be disseminated through Organizations, Churches and advocacy Groups that promote a proper Perception and Utilization of Material and Financial Resources regardless of the amount.

B.

(1) To raise the spiritual, moral, educational and social levels of the targeted group, including members of moderate, low, and very low income community, who are substantially unemployed, underemployed, or whose income is below federal poverty guidelines, to foster and promote community-wide interest and concern for the problems of said group to the end that (a) educational and economic opportunities may be expanded; (b) sickness, poverty, crime, and environmental degradation may be lessened; and (c) racial tensions, prejudice, and discrimination, economic and otherwise, may be eliminated; and (d) expound the need for establishing and fostering the **Brotherhood of Mankind**

(2) It is this purpose of the Corporation thereby to relieve the poor, distressed, underprivileged and indigent by enabling them to secure the basic spiritual and human needs and to lessen the burdens of government and promote their social welfare.

(3) To expand opportunities available to said families and individuals to interact with other Families and Individuals who are sincere about their **Spiritual Development** and the welfare and benefit of others taking the same **Journey**.

(4) To aid, support and assist through fellowship, gifts, contributions, and with other groups operated exclusively for moral, charitable, or educational purposes. No part of the net earnings of which endures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is for carrying on propaganda, or otherwise attempting to influence legislation.

(5) To do any and all lawful activities which may be necessary, useful or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organization of any kind or nature, such as corporations, firms associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.

C.

In furtherance, but not in limitation, of the foregoing moral, charitable, and educational purposes, the Corporation shall have the following powers:

(1) To solicit, collect and receive money and other assets, and to administer funds and contributions received by grant, gift, deed, bequest or devise, and otherwise to acquire money, securities, property, rights and services of every kind and description, and to hold, invest, expend, contribute, use, sell or otherwise dispose of any money, securities, property, rights or services so acquired for the purpose above mentioned.

(2) To borrow money, and to make, accept, endorse, execute and issue bonds, debentures, promissory notes, and other corporate obligations for monies borrowed, or in payment for property acquired, services rendered or for any other purposes of the Corporation, and to secure payment of any such obligation by mortgage, pledge, deed indenture agreement or other instrument or trust, or by other lien upon, assignment of or agreement in regard to all or any part of the property, rights or privileges of the Corporation.

(3) To invest and reinvest its funds in such mortgages, bonds, notes, debentures, shares and any other securities of any kind whatsoever, including property, real, personal or mixed, tangible or intangible, all as the Corporation's Board of Directors shall deem advisable and as may be permitted by law.

(4) To engage in activity of operation business ventures for the purposes of providing job training, employment services, and managerial development opportunities to said families and individuals for the charitable purpose of furthering the development of **Brotherhood** in the community.

(5) To hire and fire employees and to contract for outside services at the will of the Corporation.

(6) To engage in any and all activities which will directly or indirectly improve the **Spiritual** welfare and **Mental** conditions of said families and individuals.

(7) To exercise all rights and powers conferred upon corporations formed under the General Nonprofit Corporation Law of the state of Florida provided, however, that the Corporation shall not engage in any activities or exercise any powers, including those specifically mentioned herein, that are not in furtherance of the specific and primarily moral, charitable and educational purposes of the Corporation.

(8) The operation of said Corporation shall also include the concerns of:

- A. Child Abuse & Youth Councils
- B. Violence Prevention, including Domestic Violence
- C. Consumer Credit and Financial Counseling
- D. Talent Search and Self Expression
- E. Career and Education Research
- F. Revolving Loan Program/Business Development
- G. Housing and Historical Property Development
- H. Heritage and Political Awareness

D. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law

#### **ARTICLE V - MEMBERSHIP**

a. Any person, over the age of eighteen shall have the right to be a Member of the Organization

b. The authorized number, if any, and qualifications of Members of the Corporation, the different class of memberships, if any, the property, voting and other rights and privileges of Members and their liabilities to dues and assessments and the method shall be as set forth in the By-Laws.

c. At least one-third of the members are persons chosen in accordance with democratic selection procedures adequate to assure that there are representatives of the poor in the area served.

#### **ARTICLE VI - BOARD OF DIRECTORS**

A Board of Directors shall manage the affairs of this Corporation. The number of Directors shall not be less than three (3); provided however that the Board of Directors may, from time to time increase or decrease the number of Directors, so long as the number of directors is divisible by three (3). 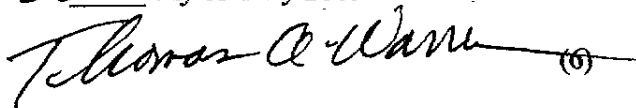

## **ARTICLE IX - DISSOLUTION**

**Upon the dissolution of and winding up of this organization, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which are organized and operated exclusively for the purposes specified in section 501 (c) (3) of the Internal Revenue Code and has established its tax-exempt status, or shall be distributed to the Federal Government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for the purposes specified in section 501 (c) (3) of the Internal Revenue Code.**

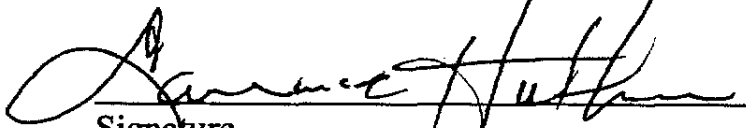
