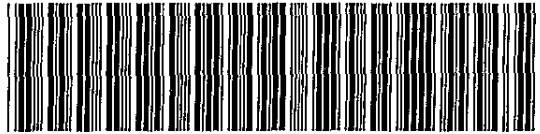

ARTICLES OF INCORPORATION OF
EXCEL OUTREACH MINISTRIES

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned incorporator, for the purpose for forming a
Corporation under the Florida Not for Profit Corporation Act,
Hereby adopt(s) the following Articles of Incorporation.

ARTICLE I
NAME

The name of corporation shall be:

ARTICLE II

ARTICLE II
PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

- a. The organization is organized exclusively for the charitable, religious, educational, and /or scientific purposes under section 501 © (s) of the Internal Revenue Code.
- b. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of their purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or engage in (Including the publishing or distribution of literature for a political campaign on behalf of any candidate seeking public office. Notwithstanding any other provision for legislation and the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal tax code, or (b) an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any further federal tax code.
- c. Upon the dissolution of the organization, assets shall be distributed from one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any further federal tax code or shall

be distributed to the federal government, or to a state or local government, for public purpose.
