Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, designing to form a Non-profit Corporation under the Non-profit Corporation Law of ACROSS CONNECTION INTERNATIONAL, INC. do hereby certify:

Article I: Name

The Name of the Corporation shall be:

ACROSS CONNECTION INTERNATIONAL , INC.

Article II: Principal Office

The Place in this state where the principal office of the corporation is to be located at 700 N. Thompson Rd. Apopka, Fl 32712 in Orange County.

Article III: Purpose

This corporation is organized exclusively for charitable, religious, educational, purposes, within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law.) including, but not limited to, for such purposes, as training for effective congregational leadership, and educational musical worship and any other activity not prohibited to corporations under the Florida

Article V: Net Earnings

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in the Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of the propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene (including the publishing or distribution of statements) and political campaign or behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

"Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article VI: Compensation

The salaries of the officers, if any, shall be fixed from time to time by resolution of the Board of Directors. In all cases, any salaries received by officers of this corporation shall be reasonable and given in return for services actually rendered to or for the corporation. Moreover any salaries, wages, together with fringe benefits or other form of compensation (housing, transportation or other allowances) paid to or provided our employees, directors or officers will not exceed value which is reasonable and commensurate with the duties

and working hours associated with such employment and with the compensation ordinarily paid persons with similar positions or duties.

The corporation would seek outside counsel for establishing what is reasonable and commensurate. The duties will disqualify themselves from all votes pertaining to their own salaries. The corporation will set up a full "Accountable Reimbursement Policy (monthly reimbursement) and an officer employment agreement.

Article VII: Dissolution

Dissolution

The terms trustees and board members shall be used synonymously for the purpose of the bylaws for this corporation.

Apopka, Fl

(a) The private property of the trustees and members of the corporation shall be non-assessable and not be subject to payment of any corporate debts, nor shall the trustees or members of the corporation become individually or corporately liable or pr responsible for any debt or liabilities of the corporation.

No part of the earning of the (b) corporation shall inure to the benefit of or the distributable to, it members, trustees, officers or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes set forth in Article Three thereof. The corporation shall not be part of, carrying on of propaganda, and attempt to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distributions of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by:

- A corporation exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).
- By corporation, Contributions to which are deductible under Section 170 (e) (2) of the Internal Revenue Code of 1954 (or the corresponding

provisions of any future United Sates Internal Revenue Law.)

- The Board of Trustees may cause the corporation to solicit, collect, receive, accumulate, administer and disburse funds in such a manner as will, in the sole discretion of the Board of Trustees, to effectively operate further purposes of the corporation.
- Upon dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for the payment of liabilities of the corporation in such manner or to such organization organized and operated exclusively for charitable purpose.

Article IX

This non-profit corporation is formed without any purpose of pecuniary profit and has no capital stock.

Article X

There shall be a Board of Trustees who shall consist of members of the organization who are at least twenty-one years of age or older, and shall be elected at the annual meeting. The Board of Trustees shall consist of a president who is presently Ada
