**1. Name.**

The name of the Corporation is Chhattisgarh University Inc.

**2. Principal Office.**

The principal place of business and mailing address of this corporation shall be:  
531, North Ocean Blvd, # 201, Pompano Beach, Florida 33062.

**3. Purpose.**

This Corporation shall be a nonprofit corporation. The Corporation is incorporated exclusively for educational, scientific, and charitable purposes, all within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as the same may be amended or modified or replaced by any future United States internal revenue law (the "Code").

**4. No Stock basis**

The corporation shall not have any capital stock.

**5. Members.**

The Corporation is to have no members.

**6. Management and Manner of Election.**

The management of the corporation shall be vested in the corporation board of directors the number of which shall not be less than three. The manner in which the directors are elected or appointed shall be set forth in the byelaws of the corporation. The powers of the Board of directors shall be as set forth in the current Bylaws.

**7. Exempt Organization.**

No substantial part of the activities of the Corporation shall be devoted to carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**8. Earnings:**

Notwithstanding any other provision of these Articles, no part of the net earnings or assets of the Corporation shall inure to the benefit of or be distributable to its members, directors, trustees, officers or any other private individual; provided, however, the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the extent that such payments do not prevent it from qualifying, and continuing to qualify, as an exempt organization and to make such lawful payments and distributions in furtherance of the purposes set forth in Article three hereof as may from time to time be either required or permitted by Section 501(c)(3) of the Code.

The corporation will admit students without regard to race, color, national and/or ethnic origin. All students shall have same rights, privileges, programs, and activities generally accorded or made available to students at the school. The corporation will not discriminate on the basis of race in the administration of its educational policies, admission policies, scholarship and loan programs, and athletic and other corporation administered programs. The corporation is aware of the requirements of Rev. Proc. 75-50 and Rev Rul. 71-447 and will comply with its requirements.

**10. Dissolution.**

In the event that the Corporation shall be dissolved or liquidated, the Board of Directors, after paying or making provision for payment of all of the known liabilities of the Corporation, may transfer or dispose of the Corporation's property and assets to (a) such one or more corporations, trusts, funds or other organizations which at the time are exempt from federal income tax as organizations described in Section 501(c)(3) of the Code and, in the sole judgment of the Corporation's Board of Trustees, have purposes similar to those of the Corporation or (b) the federal government, or to a state or local government for such purposes. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively to one or more of such corporations, trusts, funds or other organizations as said court shall determine, which at the time are exempt from federal income tax as organizations described in Section 501(c)(3) of the Code, and which are organized and operated for such purposes, or to the federal government or to a state or local government for such purposes. No private individual or entity shall share in the distribution of any Corporation assets upon sale or dissolution of the Corporation.
