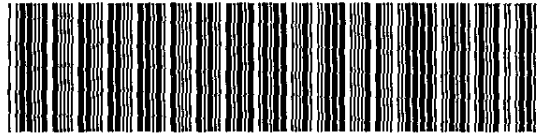

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for:  
Suwannee River Cove Ministries, Inc.,

Article 1

The name of the corporation shall be: Suwannee River Cove Ministries, Inc.

The principal place of business of this corporation shall be 1053 Louisiana Ave. Sebastian, Florida 32958

Article 11

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the date filed with the Department of State.

Article 111

The purposes for which the corporation is organized are for Charitable, Educational, Literary, and Scientific purposes, including for such purposes as making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code of 1954, (or corresponding provision of any future United States Internal Revenue Law).

Article 1V

The membership of this corporation shall constitute all persons hereinafter named as incorporators, and such others as, from time to time hereafter, may become members in a manner provided in the by-laws. A two-thirds vote of members present in any regular or special meeting called for in the manner

provided in the by-laws shall elect the membership an adult United States Citizen.

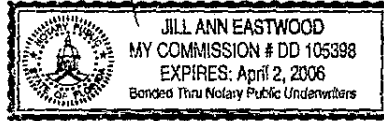
