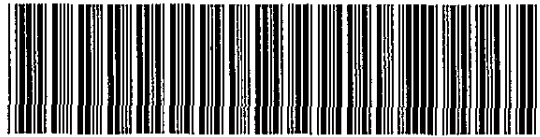

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

MT. MORIAH OUTREACH MINISTRIES INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

#1 Operate and manage a thrift store for the sale of used and/or donated goods of which the proceeds will be used for the purpose of publishing, publicizing and circulating God's Word in as many venues around the Tallahassee and surrounding areas as God will allow us to (gospel tracts, flyers, newspaper ads, weekly periodicals, monthly periodicals, mail outs, billboards, radio, television, book shop, etc.) ***Acts 1:8, II Corinthians 5:9-11***

#2 Distribution of Bibles and CHURCH tracts to as many individuals who are in need of them in the Tallahassee and surrounding areas as possible (those who are won to Christ and/or do not already own a King James Bible ***Romans 10:13-17***

#3 Assisting the CHURCH in providing aid and assistance to as many families in the Tallahassee and surrounding areas as possible in an effort to minister to their spiritual needs SEE #2 (clothing, food, furniture, etc. as becomes available through donations and/or contributions) ***Matthew 25:34-40***

#4 Assisting the CHURCH with funding for providing transportation to and from church to as many people as possible in the Tallahassee and surrounding areas who cannot otherwise get to church (elderly, disabled, Sunday school children, those who do not have transportation of their own, those who rely on others for transportation) ***James 1:27***

#5 Providing ministry work as employment for CHURCH members who otherwise are compelled to work secular jobs (with the understanding that God has led them to serve in this way) ***Titus 3:8, I Timothy 5:18***

#6 As God leads and provides we could look forward to the future concerning encouraging the start up and/or support of other outreach ministries (boys ranch, battered women's shelter, neighborhood Bible clubs, vacation Bible schools, and any other CHURCH related work designed and intended for the purpose of spreading God's Word and the gospel of Christ to the end of bringing others to salvation in Jesus Christ, etc.) ***Mark 11:22-24***




