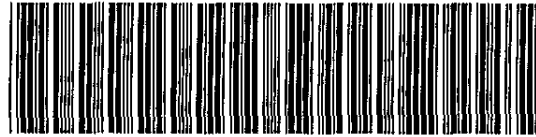

**ARTICLES OF INCORPORATION**  
(Non-Profit, Religious, Charitable)

**ARTICLE I NAME**

The name of the corporation shall be "APOSTOLATE OF THE PRECIOUS BLOOD, INC."

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

This organization was established exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code.

It was organized for the primary purpose of teaching and spreading the Devotion to the Precious Blood of Jesus Christ; for both the prayer and financial support of our priests, religious, and the poor among us; and through the sale of our gift shop items to support this work, all within the framework of the 501(c)(3) section of the Internal Revenue Code.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the Board of Directors are elected or appointed is as follows: All Board Members must be Consecrated to the Precious Blood of Jesus Christ by the method outlined in our prayerbook "Devotion to the Most Precious Blood of Our Lord Jesus Christ." They must be actively participating in at least the minimum daily prayers, Gethsemane Hours, and the Great Month of July novenas. They are appointed for a term of one year of service effective from July 1<sup>st</sup> until June 30<sup>th</sup> of the following year by the Director of the US Headquarters. Board Members can be reappointed without term limits indefinitely.

**ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS**

The Board Members are appointed by the Director of the US Headquarters of the Precious Blood for a term of one year beginning July 1<sup>st</sup> and terminating the following June 30<sup>th</sup>. The 2005-2006 Year of the Eucharist Board Members are:

**ARTICLE IX IMPORTANT DATES**

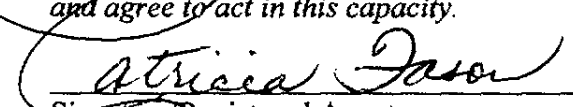

The effective date of the Incorporation is Tuesday, May 31, 2005 – The Feast of the Visitation.

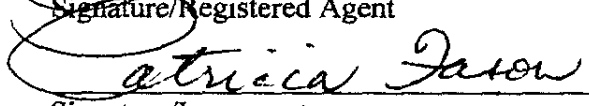
The first formal meeting of the Members of the Board of Directors will be Friday, July 1, 2005 – The First Friday of the month dedicated to the Precious Blood.
