
Please forgive me! Somehow I managed to pay for the wrong number on our submission last year to Sunbiz.org.

I am the Registered Agent for both corporations, but somehow, I accidentally paid to renew N09000009461 in place of N05000005614. I paid the renewal fee from the account of the Association of the Precious Blood but applied it inadvertently to the other entity that was dissolving since it never made any money. This was my mistake, but once it was noted in the Association's account that Sunbiz.org had been paid, they never filed the 2016 update assuming that it had been done, since the payment was made for it. Likewise, no one noticed the other account was paid, since it had already been decided to dissolve it.

We tried to resolve this issue when it was brought to our attention in late September, but we were recovering from the catastrophic damage caused by a huge tree that destroyed our offices during hurricane Hermine on September 1st. We called and tried to resolve the issue at that time, but many of our records were lost in the flooding that occurred inside our office. We were struggling to survive after that storm for months, and are only now beginning to turn the corner and get back to our ministry.

I will be far more careful in the future. Again, please accept my apologies for the mess I have made and allow this ministry to continue their very valuable work in the world from their headquarters here in Tallahassee.
