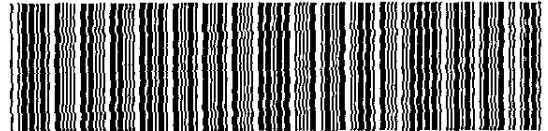

## **Articles of Incorporation**

### ARTICLE I Name

Name: The name of the corporation shall be Casa Bianca Community Development Corporation.

### ARTICLE II Principal Office

The principal office of the corporation is in the State of Florida and shall be located in Monticello at the following address, 374 Pinney Woods Road Monticello, Florida 32344.

### ARTICLE III Purpose

The Casa Bianca Community Development Corporation is organized and shall be operated exclusively for charitable, religious and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the current and relevant section of the Internal Revenue Code. The Casa Bianca Community Development Corporation shall be a private non-profit organization committed to making the community a better place through educational enrichment and mentoring, community outreach, affordable housing, weatherization enhancements, improving literacy, counseling, the arts, job training, recreation opportunities for seniors and youth, health care and prevention.

### ARTICLE IV Manner of Election

By the Founder

Members and officers of the Board of Directors shall be elected, by secret ballot, by a majority of the active Directors. Balloting shall take place at the annual meeting. Ballots must be cast in person at the meeting. Vacancies occurring during the year may be filled by a majority vote of the Board of Directors. Removal of Directors: Any Director may be removed by the Directors, whenever in their judgment the best interests of the corporation will be served thereby, by vote of a majority of the total number of active Directors.
