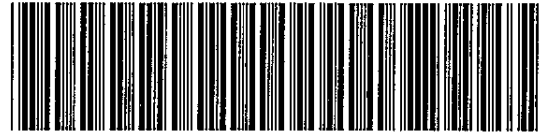



We wish to inform you of the following: The process of election of the pastor of the church and of the other directors happened in assemblies called in strict accord to these ends:


- 1- Pastor Dylmo Pereira Castro was elected in the general assembly in September of 2003. He was officiated on the third of April of 2004.
