## ARTICLES OF INCORPORATION OF STRENGTH IN ACTION. INC. A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned persons, acting, as incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statues, adopt the following Articles of Incorporation for such corporation:

#### Article I

Name of the corporation: Strength In Action, Inc.

#### Article II

#### Article III

The corporation is a not for profit corporation. The general purpose for which the corporation is formed is to provide Social Services, and Educational Intervention to at-risk youth and their families through utilization of Family Support Services, Computer Technology aided educational enchantment, Career development, after-school programs, Sports, and human needs assistance.

In addition, this corporation shall operate for religious, charitable and

#### Article IV

The corporation is organized upon a non-stock basis as defined in 617.0202 of the Florida Statutes. The corporation shall have a board of directors. The manner in which the directors are elected are stated in the BY-LAWS.

#### Article V

There are no provision which limits the corporate powers authorized under section 617.0202, Florida Statues.
