**ARTICLES OF INCORPORATION OF  
WORLDWIDE OUTREACH MINISTRY:

To the Secretary of State  
Of the State of Florida:

We, the undersigned, acting as incorporators of a corporation under Florida Non Profit  
Act, adopt the following Articles of Incorporation for such corporation.

**ARTICLE I: NAME.**

The name of this corporation is: WORLDWIDE OUTREACH MINISTRY: ANOINTING  
NATIONS, Inc.

**ARTICLE II: EFFECTIVE DATE**

The effective date is May 15<sup>th</sup>, 2005.

**ARTICLE III: PLACE OF BUSINESS**

The registered office address is 3300 Pembroke Rd #335- Pembroke Park, Fl 33023  
The registered Agent is Rev. Mercedes del Valle Herrero.

**ARTICLE IV: NAME OF INCORPORATORS**

Their names are: Rev. Mercedes del Valle Herrero, 3300 Pembroke Rd # 335- Pembroke  
Park, Fl 33023 and Rev. Maria Josie Cooney 11670 Jacob Blvd, Port Saint Lucie, Fl.

**ARTICLE V: PURPOSE**

The purpose of this corporation shall be the propagation and dissemination of the gospel  
of Jesus Christ as stated in the Holy Bible, through the preaching, teaching and living of  
the full Gospel message as outlined in the Articles of Faith of Worldwide Outreach  
Ministry: Anointing Nations, Inc. To accomplish such purposes the corporation may  
with another other means, establish Churches, Places of Worship, Healing Rooms,  
Counseling Houses, Christians Libraries, Christian Schools, Colleges and Universities,  
Houses for the Elders and Orphans, Thrift Stores, Evangelistic Crusades worldwide, and  
ultimately be engaged in all types of religious, educational and charitable activities  
worldwide including evangelism through Broadcasting, establish AM and FM Radio  
stations worldwide, telecasting, establishing TV Stations worldwide, Internet and  
Broadband services, cable and satellite television, print books, magazines, flyers or  
advertisement in any media, and other related projects for the carrying out of these  
ministries.

**ARTICLE VI: RIGHTS**

It shall have the right to posses, buy, mortgage, sell, lease, barter and exchange real and  
personal property, to borrow money, collects funds, receive gifts and legacies as it may  
judge necessary for the attainment of these purposes. This corporation is organized and

operated exclusively for religious purposes, no part of the net earnings shall insure to the benefit of any private individual. No substantial part of the activities shall consist of the participating in, intervention in the publication or distribution of statements of any political campaign in behalf of any candidate for public office.

#### ARTICLE VII: BOARD OF DIRECTORS

The method of election of Directors is as stated in the bylaws.

The following persons were chosen to be the initial Board of Directors.

Secretary: Rev. Maria Josie Cooney, 11760 Jacob Blvd. Port Saint Lucie Fl

Treasurer: Rev. Abigail Benitez, 3300 Pembroke rd #335- Pembroke Park, Fl 33023.

#### ARTICLE VIII: MANAGEMENT OF AFFAIRS

The management of affairs of Worldwide Outreach Ministry: Anointing Nations, Inc is vested in the President (Chairman of the board) and the Board of directors. The corporation shall be governed by the provisions contained in its Constitution and Bylaws. The President, until her voluntary resignation or death is Rev. Mercedes del Valle Herrero.

#### ARTICLE IX: MEETINGS

The annual meeting of the corporation shall be held as stated in its Constitution and bylaws.

#### ARTICLE X: PROPERTY

Section 1: Documents relating to the conveying or encumbering real estate shall be signed by the President and other board Member as the secretary.

Section 2: All property of this corporation should be recorded in the name of the corporation. In the event of a defection of any member of this corporation from its Articles of Faith, or from affiliation with Worldwide Outreach Ministry Anointing Nations, Inc. the title of all corporation property, real or personal, shall remain with those members abiding such Articles of Faith and retaining affiliation with Worldwide Outreach Ministry Anointing Nations, Inc.

#### ARTICLE XI: DURATION

The period of this corporation is perpetual.

#### ARTICLE XII: DISSOLUTION

In the event of dissolution of this Non Profit Corporation, all its property shall pass to an organization determined by the board of Directors of this corporation whose purpose is in harmony with the full Gospel message as outlined in these corporation Articles of Faith. Such organization must be organized and operated exclusively for the purposes specified in Section 501 © (3) of the Internal Revenue code.

#### ARTICLE XIII: ADMENTMENTS

These articles may be amended by a simple majority vote of the Board of directors present at duly called meeting where all board Members are notified in written with a minimum of 10 (Ten) days prior to the Meeting. The President must be present at this Meeting.

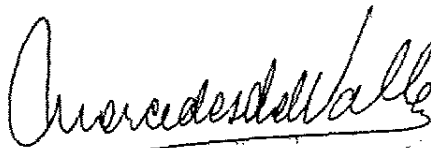
