**ARTICLES OF INCORPORATION
OF
SPRINGS OF LIVING WATER PRISON MINISTRIES, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation.

ARTICLE I: NAME

The name of the corporation will be, SPRINGS OF LIVING WATER PRISON MINISTRIES, INC.

ARTICLE II: PRINCIPAL OFFICE:

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSES:

This corporation will be a corporation NOT-FOR-PROFIT and the specific purposes for which the corporation is organized are:

- A. To bring in a practical way, light, hope, and healing through the Gospel of Jesus Christ to people currently in prison, regardless of their race, religion, ethnicity, etc.
- B. To motivate and mentor individuals to reach their maximum potential through practical and hands-on Biblical based teaching methods.
- C. To serve as a legal entity to own property, handle the business affairs of this corporation and to maintain offices in other countries, with power to perform all acts not inconsistent with the aims and objects of same.
- D. The purposes for which the organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

- E. To perform all functions and to have all powers as permitted by Chapter 617, Florida Statutes 1987, and such powers as corporations not-for-profit may otherwise now or hereafter have or acquire; provided, however, that this corporation, in exercising any or more of such powers shall do so in furtherance of the exempt purpose for which it has been organized as described in Section 501 (c) (3) of the Internal Revenue Code of 1986 or the correspondent provision of any future United States Internal Revenue Law.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS/OFFICERS:

- A. The affairs of this corporation are to be managed by a board of Directors. The board of Directors shall perform those instruments as are required by law of corporation or any other legal requirements or any other matters directed by the members and shall have the responsibilities, duties, and privileges as designated by the members and as set forth in the By-laws. The Board of Directors shall select from its number: a Vice-Chairman, who shall be the Vice-President of the corporation; a secretary, who shall be the Secretary of the Corporation; a Treasurer, who shall be the Treasurer of the Corporation; and other officers as may be provided for in the By-Laws. The number of Directors, their terms of office, the manner of their selection, and duties and responsibilities shall be provided for in the By-Laws, provided however, that their number shall never be less than three.
