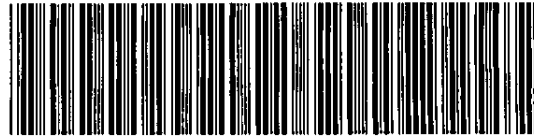



**ARTICLES OF DISSOLUTION  
OF

Pursuant to the provisions of Section 617.1403 of the Florida Business Corporation Act, **Eurasian Communication Association of North America, Inc.**, a Florida not-for-profit corporation (the **Corporation**), hereby submits the following Articles of Dissolution:
