In compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

The name of the corporation shall be Friends of Oakcrest Incorporated

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

The purpose of the organization is to oversee and protect the interests of those persons with buried pets or cremains at Oakcrest Pet Cemetery. Overseeing future burials of pets will be provided on a donation basis for the burial costs and any materials (casket or markers) to be provided at cost. This service will be limited to persons with pets already buried at Oakcrest Pet Cemetery and service animals (police dogs for example). Donations will also be accepted to assist with beautification of the property such as flowers and holiday decorations.
