ARTICLES OF INCORPORATION

Article I Name of the Corporation

The name of the corporation shall be: Attucks High School Alumni Association, Inc. Hereinafter shall be referred to as the "Association".

Article III Purpose

The purposes for which this Association is formed are exclusively charitable, educational and scientific and shall advocate the following objectives:
