

Articles of Incorporation

We, the undersigned persons of the State of Florida, all of whom are of legal age, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit, under the Laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

Article I - Name

The name of this organization will be: **Wings of Love and Hope, Inc.** With its principal place of business locate at:

830 California Woods Circle
Orlando, Florida, 32824

Article II - Purpose

The general purpose of this corporation is as follows: To help people in need in our community:

- A. Physical need of food and clothing.
- B. Emotional need of orientation and counseling

Article III - Property

The Corporation shall have the power to buy, acquire and hold title in fee simple, in trust or otherwise, to both real and personal property and improve, encumber, sell, convey and dispose of all such property. To borrow money, execute notes, bonds and other evidences of indebtedness and to secure mortgages and deeds of trust, annuity bond, and other instruments of indebtedness. The said organization or its successor, without financial profit to its members, except as may be necessary in the payment of salaries, or other compensation for services rendered, and the corporation shall have the power to erect and maintain buildings to be utilized by the said organization. In conformity with the by-laws of said corporation and all the power a right granted to Corporations not for Profit under the laws of the State of Florida.

Article IV - Officers

The officers who are to manage the affairs of this corporation shall be as follows: A President, a Secretary - Treasurer and a Field Representative, which three officers shall be the Trustees of the corporation, and they shall be appointed by the executive board of our organization, in accordance with the bylaws, and each shall hold office until his successor is appointed and qualified. Article V - Board of Directors
